We are writing to invite you to the AGM of Routes to Roots (Poole) CIO), which will be held on Tuesday 9<sup>th</sup> January 2018 from 7pm at Skinner Street URC.

Since Routes to Roots first became a registered charity in 2002 our work has become more widely acknowledged and accepted in the town. Our operations are centered at Skinner Street URC from where we give assistance to those in need – vulnerably housed as well as homeless people. This includes: two lunch time drop-ins with light lunch, two evening drop-ins with cooked meal, breakfast vouchers for rough sleepers from December to March, one to one support for benefits claims, calls to agencies, doctors, landlords, etc., one to one professional counseling, referrals to other agencies, postal care-of address, access to landline telephone, chiropodist and hairdressing services, clothing, toiletries, sleeping bags, food, etc.

We have also continued to provide supported accommodation in Poole, through a partnership with a national charity Green Pastures.

Thank you so much for your support, and we also ask for your prayers for all our supporters, workers and volunteers, and especially for the homeless and vulnerably housed.
